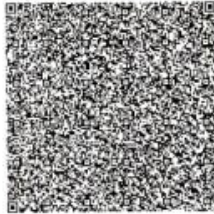

This memorandum of Understanding (MOU) made and executed on this **First day of July 2013** between **HIRASUGAR INSTITUTE OF TECHNOLOGY**, an educational Institution in Engineering & Technology and located at Nidasoshi, Pin – 591 236, Karnataka State and represented by **Dr. N.C. Hiremath, Principal** herein after called **Hirasugar** (Which expression shall include its successors and assigns) of the first part:

PROLIFIC SYSTEMS AND TECHNOLOGIES PVT. LTD., a company registered and having its Branch office at No: 15, 12th Block, 5th Main, Kumara park West, Bangalore – 560 020, and represented by, **Mr. R. Anantharaman, Associate Director**, herein after referred to as **Prolific**, which term shall mean and include,

unless repugnant to the context and meaning thereof, its Successors, legal representatives and assigns, of the other part:

And whereas both **Hirasugar & Prolific** have agreed to form a '**strategic Alliance**' for providing a course with placements to the Engineering students for mutual benefit.

And whereas, on the faith and strength of such representation and warranty, both **Hirasugar** and **Prolific** have agreed to enter in to this MOU as per the mutually agreed clauses as agreed below:

Prolific will conduct a **PGDIA** (Post Graduate Diploma in Industrial Automation) course at the Hirasugar Institute of Technology premises for the Final Year EEE students.

The details are as follows:

1. The duration of the training will be 30 days – 6Hrs Per Day; Total – 180 Hrs; in the months of July – August 2013.
2. The training will be conducted at mutually convenient dates.
3. Two faculties will be from Prolific.
4. Required hardware and software will be arranged by Prolific
5. Hirasugar shall take care of the lodging & boarding of 2 faculties from Prolific on training days.
6. Hirasugar shall provide the necessary infrastructure as required by Prolific for conducting the training program.
7. **Placements:** Prolific assures **100% placements** to all the students who enroll for this PGDIA program.
