Roles & Responsibilities

- Conduct a meeting twice in a semester & maintain the minutes of meetings.

- Maintain affidavits by students and parents.
- Display of posters with a list of committee members and their contact numbers, provisions of law, punishment etc. at hostels, institute buildings and on departmental notice board.
- The counseling/ induction session should be arranged for fresher's after admission process is done.
- On receipt of the recommendation of the Anti Ragging Squad or on receipt of any information concerning any reported incident of ragging, the Head of institution shall immediately determine if a case under the penal laws is made out and if so, either on his own or through a member of the Anti Ragging Committee authorized by him in this behalf, proceed to file a First Information Report (FIR), within 24 hours of receipt of such information or recommendation, with the police and local authorities, under the appropriate penal provisions relating to one or more of the following, namely: Abetment to ragging, Criminal conspiracy to rag, Unlawful assembly and rioting while ragging, Public nuisance created during ragging, Violation of decency and morals through ragging, Injury to body, causing hurt or grievous hurt, Wrongful restraint or Wrongful confinement, Use of criminal force, Assault as well as sexual offences or unnatural offences, Extortion, Criminal trespass, Offences against property, Criminal intimidation, Attempts to commit any or all of the above mentioned offences against the victim(s), Threat to commit any or all of the above mentioned offences against the victim(s), Physical or psychological humiliation and other offences following from the definition of "Ragging".

HIT Internal Complaint Committee (ICC)/ Anti Sexual Harassment Committee

Preamble:

Prevention of Sexual Harassment of Women at Workplace or the classroom violates human rights and other laws. It is imperative that one is able to identify sexual harassment conduct and knowing how to respond to it. This is critical both for the individual as well as for Society.

HIT's position:

HIT is committed to upholding the Constitutional mandate to combat sexual harassment of women and ensure that human rights of all those who fall within its jurisdiction are safeguarded. Internal complaints committee was formed in August 2016 to act as a vehicle to address the issue of sexual harassment of women in the institute.

Objectives:

1. To increase knowledge about prevention of sexual harassment of women at workplace.
2. To sensitize all stakeholders to recognize that sexual harassment can cause mental and physical harm to the victim.
3. To promote dialogue about sexual harassment in the academic community.
4. To provide guidelines for addressing sexual harassment.

What is sexual harassment?

* Unwelcome sexual advances, requests for sexual favors, other verbal or physical conduct of a sexual nature such as loaded comments, remarks or jokes, letters, phone calls or emails, gestures, exhibition of pornography, lurid stares, physical contact, stalking, sounds or display of a derogatory nature.

* When a person/s uses, with a sexual purpose, the body or any part of it or any object as an extension of the body in relation to another person without the latter's consent or against that person's will, such conduct will amount to sexual assault.

* When deprecatory comments, conduct or any such behavior is based on the gender identity/sexual orientation of the person and/or when the classroom or other public forum of HIT is used to denigrate/discriminate against person(s), or create a hostile environment on the basis of a person's gender Identity/ sexual orientation.

When?

* Submission to such conduct is made either explicitly or implicitly a term or condition of teaching / guidance, employment, participation or evaluation of a person's engagement in any Institute's activity.

* Such conduct has the purpose or effect of interfering with an individual's performance or creating an intimidating, hostile, or of creating an intimidating, hostile or offensive environment.

Sexual harassment:

VERBAL: Unwelcome comments/sexual epithets.

VISUAL: Offensive pictures/photos/cartoons.

PHYSICAL: Unwelcome physical contact. Standing too close/ogling/suggestive gestures.

WRITTEN: Unwelcome personal letters/e-mails.

DUTIES AND RESPONSIBILITIES OF ICC (Internal Complaint Committee)

1. Creating awareness about ICC among students and staff.
2. To take cognizance of complaints about sexual harassment, conduct enquiries, provide assistance and redressal to the victims, recommend action to be taken against the harasser, if necessary.
3. To recommend arrangements for appropriate psychological, emotional and physical support (in the form of counseling, security and other assistance) to the victim if s/he so desires.
4. To play a preventive role by making efforts to provide a congenial atmosphere at the institute by arranging periodic programmes and lectures, if required, on prevention of sexual harassment of women at the Institute.
5. To net as Inquiry Authority on a complaint of sexual harassment.
6. To ensure that complainant and witnesses are not victimized or discriminated because of their complaint.

7. Communicate to the harasser that his conduct is offensive and unwelcome.
8. Keep records of any verbal or written communication you have with the harasser.
9. It is not necessary that you personally confront the harasser. If you are uncomfortable, seek help of **HIT** Internal Complaint Committee (ICC)

When you need help...

- Talk to or email any member of the Internal Complaints Committee (ICC).
- Complain orally or in writing to any member of the HIT Internal Complaints Committee (ICC).
- Remember... filing of a complaint WILL NOT adversely affect your career/grades/ academic status.

What happens to a complaint?

- If the aggrieved person wishes to, the ICC may take steps to settle the matter between the complaint and the respondent through conciliation.

If settled, the ICC will record the settlement and recommend no further action.

Where the aggrieved person does not request conciliation, ICC initiates an enquiry.

- ICC will complete the enquiry and submit a report to the Principal, HIT within a month.
- The Principal, HIT will initiate action within 10 days of receipt of report.

During the enquiry

- All proceedings will be kept confidential.
- All efforts will be made to ensure that the complainant and witnesses are not discriminated against or penalized by the respondent.

What HIT expects from you

- Behave appropriately.
- Speak up if you come across sexual harassment.

Help HIT provide a safe and respectful environment for all.

Roles and Responsibilities

I. Objectives

1. To develop an organizational frame work to resolve grievances of the Students and other stake holders.
2. To enlighten the student on their duties and responsibilities to access benefits.
3. To investigate the reason of dissatisfaction and ensure swift and effective solution to the grievances of Students and other stakeholders.

II. Powers of the Committee

1. The grievances committee shall deal with the grievances of Teachers, other Employees and the students.
2. The aggrieved person (Teacher, other Employee or students) of any constituent college may lodge his grievance with the committee at the earliest.
3. The Grievance committee shall hear and settle grievances, as far as may be practical within three months after the grievance is lodged with the committee.

III. Grievance Redressal committee shall receive and redree grievances reported of following issues

1. Academic issues: pertaining to teaching learning activities.
2. Pertaining to harassment between Students- Teacher, Students- Students, and Students- Parent relationships, etc.
3. Internal evaluation and assessment marking.
4. Complaint related to library and it services.
5. Grievances related to hostel, food, water, electricity etc.
6. Grievances related to transport facilities.
7. Grievances related to sports cultural and selection process.
8. Grievances related to women issues and harassment, However they are specifically redressed by women welfare and anti sexual harassment committee.
9. Grievances related to ragging and however the matter is referred to anti ragging committee for appropriate Redressal.

IV. The grievance shall be redressed depending on the nature of grievances.

1. Department level counseling, college / institutional level counseling where the matter can be resolved through these efforts.
2. Most of the academic / internal evaluation (grievances related to internal assessment) shall be redressed at individual faculty level, HOD or Dean / Principal.
3. For other grievances that required review shall be redressed by receiving written and signed application.
4. As soon as the application is received the Redressal committee shall review the complaint and visit the parties for discussion. The grievances at this level shall be resolved by issuing warning letters, memos and reformulation remedies.
5. The grievance that need detailed Investigation shall be subjected to enquiry by team of Independent members. Enquiry report along with recommendation related to punishment shall be sent to the University grievance cell which in turn communication it to concerned individual.
6. The matters concerning to women harassment and ragging shall be dealt by respective committees as per the laid down procedures.
