
### Minutes of meeting

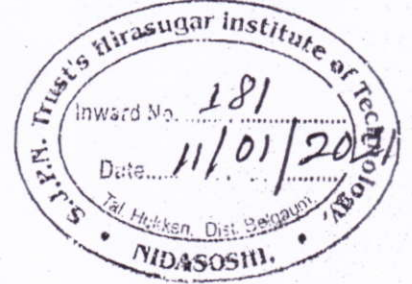




