MEMORANDUM OF UNDERSTANDING (MOU)

BETWEEN

Sharad Institute of Technology College of Engineering, Yadrav

(SITCOE, YADRAV)

And

S.J.P.N Trust's Hirasugar Institute of Technology, Nidsoshi, Karnataka

(HSIT, Nidsoshi)

This MoU is entered on the DATE 6th September 2023 by and between Sharad Institute of Technology College of Engineering, Yadrav (herein after called as SITCOE) situated at Yadrav, Tal-Shirol, Dist-Kolhapur and S.J.P.N Trust's Hirasugar Institute of Technology, Nidsoshi, Karnataka (herein after called as HSIT)

Whereas, SITCOE is An Autonomous Institute and one of the budding and emerging engineering colleges in the Maharashtra state which is approved by AICTE, New Delhi and recognized by Government of Maharashtra, and affiliated to Dr. Babasaheb Ambedkar Technological University, Lonere and provides excellence in Science & Technology.

Whereas, HSIT is one of the reputed engineering institutes in the Karnataka state which is approved by AICTE, New Delhi and recognized by Government of Karnataka, and affiliated to VTU Belgavi.

WHEREAS, both SITCOE and HSIT now;

- Recognizing the importance of development in the areas and scope for young graduates as well as faculties to work with, as well as imparting professional industrial training to the engineering students, etc.

- Appreciating the need for training for undergraduate students and making them capable of onsite job responsibility and creation of a large reservoir of highly qualified manpower in all fields related to the development of software and various kinds of engineering applications etc.
- Desiring to club their efforts by pooling their expertise and resources.

NOW, THEREFORE, in consideration of the mutual promises made herein and of good and valuable consideration, the receipt and sufficiency of which both **SITCOE** and **HSIT** hereby acknowledge, **SITCOE** and **HSIT** hereby agree to sign a memorandum of understanding (**MoU**).

ARTICLE-I: SCOPE OF THE MOU

This MoU details the modalities and general conditions regarding collaboration between **SITCOE** and **HSIT** for providing a platform for professional training /site exposure to enhance practical knowledge during educational curriculum and best utilization along with the availability of highly qualified manpower in the areas of all engineering services without any prejudice to prevailing rules and regulations in **SITCOE** and **HSIT**. So far such a mechanism applies to **SITCOE** and **HSIT**. The areas of cooperation can be extended through mutual consent.

ARTICLE-II: SCOPE AND TERMS OF INTERACTIONS:

Both **SITCOE** and **HSIT** shall encourage interactions between the faculty members, Engineers/ Students, and respective teams of both institutes through the following arrangements:

1. Visits between the Departments by academic, technical, and administrative staff.
2. Exchange of materials in education and research, publications, and academic information.
3. Collaborative R&D, Consultancy and publication.
4. Joint organization of conferences, seminars, or other academic meetings.
5. Joint organization of technical training, students' internship technical events, or administrative programs.
6. Use of research laboratory facility for UG, PG & PhD project work.
7. Intercollege competitions

ARTICLE-III: Publicity and Advertising

The parties agree that each may publish or advertise the existence and nature of activity under this MoU. Nothing in this agreement shall be construed as confidential.

ARTICLE-IV: Duration of MoU:

1. This MoU will be effective upon signature by the Head of Institute/Dean for a period of **TWO** years, at which time it will be reviewed for possible renewal.
2. During its tenancy, the MoU may be extended or terminated by a prior notice of not less than one month by either party. However, termination of the MoU will not in any manner affect the interests of the students/faculty who have been admitted to pursue a program under the MoU.





