# Sub: Letter of Offer and Terms of Employment

#### Dear Priyanka

This is with respect to your application for exploring career opportunities with Finonyx Software Soltuions Pvt. Ltd. You have successfully cleared the initial selection process and we are pleased to make you an offer, initially as a Trainee and on successful completion of the Training, of employment in the Company as per the terms and conditions mentioned below. You are required to carefully read and understand these Terms of Employment as a part of accepting this Offer.

We are pleased to offer you the position of **Software Trainee** with Finonyx Software Solutions. We are excited. about the potential that you will bring to our organization.

Your initial compensation package includes a monthly stipend of INR Twenty Thousand only (Rs. 20,000/ with 10% TDS deduction

You will be on Training for a period of six months from the date of joining. The company shall extend the period of your Training to max 2 months, if needed and if your performance is not found satisfactory even after extension of the Training period, the company shall have right to terminate your training without assigning any reason thereof.

During the period of Training, you will not be entitled to any other benefits, which may be available to the permanent employees of the company.

**Working Hours:** Your normal working hours are from 9.30 am to 6.30 pm, Monday to Friday, with one-hour, lunch break

**Leave**: During Training you are allowed for one days of leave per month which is not carried forward. In case you are on leave for more than 2 days per month, the stipend would be reduced accordingly.

**Confidentiality, Data and Intellectual Property Protection:** As part of the joining formalities, you are required to sign a confidentiality agreement, Non-Disclosure Agreement which aims to protect the intellectual property rights and business information of Finonyx and its clients.

#### **Data Privacy:**

Your personal data collected and developed during recruitment process will be processed. The personal data referred therein are details related to contact, family, education, personal identifiers issued by government, social profile, background references, previous employment and experience, medical history, skillset, proficiency and certifications, job profile and your career aspirations.

It will be processed for various organizational purposes such as recruitment, onboarding, background check, project assignment, performance management, job rotation, career development including at leadership level, diversity and inclusion initiatives, global mobility, statutory and legal requirements and specific organizational initiatives in force during your tenure in Finonyx.



After you join Finonyx, there would be more sets of Personal Information (PI) attributes processed for various legitimate purposes. All of it will be processed with compliance to applicable laws. In some scenarios of your PI processing, you will be provided with appropriate notice and/or explicit consent might be obtained from time to time.

If for any reason you wish to resign from the Training, you may do so by giving 1 (One) month notice in writing or pay the company 1 (One) months salary in lieu thereof, Similarly the company can at its discretion terminate your training by giving one month notice in writing or 1 month salary in lieu thereof at the sole discretion of Finonyx. The notice period will be 2 months during probation once you are employed after successful completion of the training. Beyond six months of employment your services are mutually terminable with a notice of three months or salary in lieu thereof at the sole discretion of Finonyx.

The Company also reserves the right to terminate your training services summarily without any notice period or salary in lieu thereof, if it has reasonable ground to believe that you are guilty of misconduct or negligence or nonperformance or have committed any fundamental breach of these terms or caused any loss to the Company. Such termination by the Company shall not affect any other claims the Company may have against you, in law and/or in equity

This contract of training and later of employment may be terminated without notice or any compensation in lieu thereof, if any act of yours is detrimental to the interest of the Company after due process of law.

If any time you are found guilty of dishonesty, disobedience, disorderly behavior, negligence, indiscipline, absence form duty without permission and/or any other conduct which is considered by the Company detrimental to the interest of the Company or violation of one or more terms of this letter, your training and/or employment can be terminated without notice.

Moreover, if and when the Management feel suspicious about your integrity or loose confidence in you, your training and/or employment is liable to be terminated after due process of law.

You will be governed by the code of conduct of the company and if there is any breach of the same or nonconformance of contractual obligation or with the terms and conditions laid down in this agreement, your training can be terminated without any notice; notwithstanding any other terms and conditions stipulated herein the company reserves the right to invoke other legal remedies as it deems fit to protect its legitimate interest. You agree that Finonyx may terminate your training and later employment without notice in the event of willful or serious misconduct on your part, which includes, but is not limited to, theft, fraud, misrepresentation, dishonesty, assault, drunkenness, or being under the influence of illicit drugs, refusing to carry out a lawful and reasonable direction or serious breach of our policies.

If you accept this offer, we request to present for the training on the stipulated date and time. If not accepted within 3 days, this offer is liable to lapse at the discretion of Finonyx.
